## Instrucțiuni importante de siguranță

- Deconectează receiverul de la sursa de curent înainte de a-l conecta la alte echipamente.
- Nu deconecta cablurile de semnal și AV în timp ce aparatul este pornit.
- Scoate cablul de alimentare din priză dacă receiverul nu este folosit pentru o perioadă îndelungată de timp.
- Atunci când muți receiverul dintr-un mediu cald într-unul rece, sau viceversa, oprește receiverul și pornește-l după 1-2 ore.
- Fereşte receiverul de ploaie sau orice alt lichid. Nu aşeza obiecte ce conțin lichide pe receiver. Dacă intră lichid în receiver, scoate cablul de alimentare imediat pentru a evita apariția flăcărilor sau șocurilor electrice.
- Pentru a asigura o ventilație bună, nu acoperi gurile de ventilație cu ziare, perdele sau alte astfel de obiecte.
- Nu așeza obiecte grele deasupra receiverului.
- Deconectează cablul de alimentare înainte de curățarea receiverului. Șterge suprafața exterioară a receiverului cu o cârpă uscată.

#### Mediul de instalare

- Pentru o ventilație bună, păstrează minimum 10 cm distanță între receiver și alte obiecte.
- Nu aşeza obiecte ce produc căldură în jurul aparatului (ex. lumânări, radiator, calorifer, sobă, amplificator).
- Temperatura camerei în care se află receiverul trebuie să fie moderată.
- Evită umiditatea ridicată.
- Evită lumina directă a soarelui.
- Evită vibrațiile puternice.

### Instrucțiuni pentru priza electrică și cablul de alimentare

- Asigură-te că priza electrică se află în apropierea aparatului și că este bine fixată.
- Nu atinge cablul de alimentare cu mâinile ude.
- Pentru a evita incendiile sau şocurile electrice cauzate de un scurtcircuit, ce pot pune în pericol siguranța personală sau cauza daune casei, nu folosi un cablu de alimentare defect și contactează un reprezentant Orange Romania Communications pentru înlocuirea acestuia.

### Instrucțiuni pentru telecomandă și baterie

- Plasează bateriile în compartimentul pentru baterii ținând cont de polaritatea indicată prin simbolurile afișate.
- Dacă telecomanda nu este folosită timp îndelungat, scoate bateriile pentru a evita scurgerea lichidului din interior, ce poate coroda alte componente din interiorul telecomenzii.
- Înlocuieşte bateriile atunci când acestea se uzează și evită poluarea mediului înconjurător aruncându-le în locurile speciale de colectare.

## Instrucțiuni de instalare

#### 1. Conectarea sursei de semnal

Se va conecta ieșirea LNB IN a receiverului la antena parabolică. Conectarea receiverului la sursa de semnal va fi realizată de un reprezentant Orange Romania Communications.

#### Consumul de electricitate în standby

Potrivit Regulamentului Comisiei Europene 1275/2008 privind reglementarea consumului de electricitate al receiverelor de satelit, atunci când aparatele de acest tip se află în standby și nu sunt folosite pentru o perioadă de timp, este obligatoriu să intre în starea de standby pasiv, în care acestea au un consum de electricitate de 0,5W. Pentru a fi în conformitate cu aceste reglementări, receiverul va intra în modul de standby pasiv după aproximativ 3 ore de la închiderea acestuia din panoul frontal sau din telecomandă. În plus, poți comuta receiverul în starea de standby pasiv prin apăsarea butonului de standby de pe telecomandă timp de 5 secunde, dacă ești în modul vizualizare, sau timp de 3 secunde, dacă receiverul este în standby activ. Pentru a reporni receiverul, apasă butonul O de pe panoul frontal sau telecomandă, apoi așteaptă câteva momente până când receiverul își va relua activitatea. Astfel, vei contribui la un consum mult mai mic de electricitate atunci când nu folosești receiverul.



### 2. Conectarea TV-ului

Televizorul poate fi conectat la receiver în două moduri: prin intermediul cablului HDMI sau prin intermediul cablului RCA.

Notă: Asigură-te că televizorul tău este setat pe modul input/sursă HDMI.

Dacă televizorul tău nu are un port (HDMI), poți viziona imaginile pe televizor conectând un capăt al cablului RCA la receiver și celălalt capăt la televizor.

### 3. Conectarea la sursa de alimentare

Introdu un capăt al cablului de alimentare în portul de input al receiverului și celălalt capăt în priză. Asigură-te în prealabil că priza este funcțională. Când pornești receiverul vei vedea mesajul "Please wait" (Așteptați) și apoi va fi afișat canalul cu numărul cel mai mic.

### 4. Instalarea cardului de vizionare

Fanta pentru cardul de vizionare se află pe spatele receiverului. Introdu orizontal cardul potrivit direcției indicate de săgeată.

## 5. Configurarea inițială

După efectuarea pașilor instalării, la prima pornire a receiverului, parametrii principali de funcționare trebuie să se actualizeze. Așteaptă încheierea acestei operațiuni înainte de a continua configurarea.

Pentru a putea urmări programe TV sau pentru a utiliza ghidul TV, este necesară o configurare completă a receiverului. Pentru a efectua o configurare completă, trebuie să treci prin toate ecranele de configurări. Până la finalizarea întregului proces de configurare vor funcționa numai butoanele necesare pentru aceste operațiuni.

Mai întâi va apărea un ecran pentru selectarea limbii meniului, apoi un ecran cu un mesaj în care ți se solicită să verifici dacă toate dispozitivele sunt pornite și apoi un ecran pentru setările inițiale, din care poți modifica o parte din parametri, dacă este cazul. În final, vor apărea ecranul pentru selectarea semnalului transponderului și ecranul pentru puterea și calitatea semnalului.

- Se verifică dacă receiver-ul este comutat pe un canal la care ești abonat;
- Este posibil ca abonamentul tău să fi fost suspendat temporar pentru neplata facturii sau receiver-ul nu a fost alimentat cu energie electrică pe o perioadă mai lungă de timp;

- Se restartează receiver-ul prin deconectarea și apoi reconectarea la sursa de curent.

#### Ce fac dacă pe ecranul televizorului apare mesajul: "Contactează Serviciul Clienți. Cardul de vizionare nu este autorizat pentru utilizarea în acest decodor (14)"?

Se verifică dacă smart card-ul este introdus în receiver corect.

# Ce fac dacă pe ecranul televizorului apare mesajul: "Contactează Serviciul Clienți (11)"?

- Se restartează receiver-ul prin deconectarea și apoi reconectarea la sursa de curent;
- Se scoate cardul de vizionare, se şterge cipul cu o cârpă moale și uscată, se introduce înapoi în aceeași poziție din care a fost scos.

#### Ce fac dacă emisiunile mele sunt redate în limba greșită?

 Asigură-te că ai selectat limba corespunzătoare. Accesează meniul Setări, apoi Setări Utilizator, apoi Audio și selectează limba audio dorită din listă.

#### Ce fac dacă LED-ul panoului frontal este stins?

 Verifică cablul de alimentare astfel încât să fie ataşat receiver-ului și introdus într-o priză funcțională.

#### Ce fac dacă nu am imagine?

 Verifică cablul HDMI/RCA astfel încât să fie conectat corespunzător la receiver și la TV.

### Ce fac dacă nu am nici imagine și nici sunet simultan?

- Verifică cablul HDMI/RCA astfel încât să fie conectat corespunzător;
- Verifică modul de input/sursă al televizorului astfel încât acesta să fie HDMI/RCA;
- Apasă tasta "Standby" de pe telecomandă sau receiver pentru a comuta aparatul în modul de operare dacă acesta este în Standby.

### Ce fac dacă aparatul se oprește brusc?

- Ventilația este insuficientă sau aparatul se află în preajma unui obiect ce produce căldură;
- Așează aparatul într-un spațiu răcoros și bine ventilat.

### Ce fac dacă telecomanda nu funcționează?

- Asigură-te că telecomanda este îndreptată către panoul din față și că semnalul IR nu este obstrucționat în niciun fel;
